

## 6.1.2 SCHOLARSHIPS

### (i) Merit Scholarships

a) Full free ship on tuition fee shall be admissible to 02 students on the basis of JEE (Main) rank for the first year. If the top 02 students happen to be boys, then 01 additional full free ship on tuition fee shall be awarded to the girl student having the top JEE (Main) rank among all the girls taking admission during that year. These free ships shall be given for a period of maximum 04 years subject to fulfilment of following further conditions:

- The full free ship on tuition fee shall be continued in the 2nd and subsequent years provided the CGPA of the student continues to be  $\geq 9$ .
- The full free ship on tuition fee shall be replaced by half free ship on tuition fee in the subsequent years if the CGPA of the student is  $\geq 8.5$  but less than 9.
- The free ship on tuition fee shall be discontinued in the subsequent years if the CGPA of the student becomes less than 8.5 at any point of time.

b) In addition to scholarships in a) above, merit Scholarships in the form of full or half free ships on tuition fee (Full free ship in case CGPA is  $\geq 9$  and half free ship in case CGPA is  $\geq 8.5$  but less than 9) shall be granted every year to students of second, third and final year on the basis of branch-wise merit (on the basis of CGPA of previous year provided it is not less than 8.5) as per following details:

- Two students (if both the toppers are male students, then third scholarship may also be given which should be given to a girl student).
- One student (if topper is a male student, then second scholarship be given which should be to the female student).

### (ii) Fee waivers for social uplift of students

Half free-ship on tuition fee shall be admissible to all the students belonging to Scheduled Castes/Scheduled Tribes.

### (iii) Fee Waivers for students belonging to Persons with Disabilities Category

- Full free-ship on tuition fee shall be admissible to all the students belonging to Persons with Disabilities Category whose annual family income does not exceed Rs. 5,00,000/-
- Half free-ship on tuition fee shall be admissible to all the students belonging to Persons with Disabilities Category whose annual family income does not exceed Rs. 10,00,000.

### (iv) Fee waivers based on annual family income of students

- Full Free-ship on fee including Hostel fee shall be admissible to all the students belonging to the BPL Category, having a BPL card issued by the Government.
- Half free ship on tuition fee shall be granted on the basis of annual family income to maximum 2 percent of students in a batch whose annual family income from all sources does not exceed Rs. 5,00,000.
- Fee waivers (half or full) will be given to only those students who have not paid school fee/coaching fees exceeding Rs. 30,000/- P.G during their secondary and senior secondary schooling in XI and XII.

The fee waivers in categories (ii), (iii) and (iv) above shall be awarded to a student subject to the fulfilment of following further conditions:

- The fee-waivers shall be awarded for the complete duration of the course i.e., for 4 years. However, the awards would be continued in the subsequent years to only those students who have cleared all their courses registered during the previous year and do not have backlog of more than 2 courses and who are not on academic probation.
- For proof of family income from all sources, income certificate shall be accepted when issued by the competent authority, which shall mean Deputy Commissioner/ Tehsildar/SDM or the employer as the case may be. In addition to this, an affidavit duly

attested by a magistrate, giving full details of the family income should also be submitted.

- The Scholarships and Prizes Committee may use other methods and may seek additional documents to ascertain the financial credentials of the applicants.

**(v) Fee waivers during emergency situations**

In addition to the above fee waivers, the Chairman Senate is fully authorized/ empowered to financially help a student on compassionate grounds in case of an emergency.

**(vi) Scholarships offered by Govt. And non-Govt. Organizations**

In addition to the scholarships given by Punjab Engineering College (Deemed to be University) mentioned at (i), (ii), (iii) & (iv) above, many other scholarships offered by various other Govt. and non-Govt. organizations are also offered to the students, as and when applicable. A few scholarships under this category are:

1. Top Class Education Scheme for SC students (Central Sector Scheme)
2. Top Class Education Scheme for Student with Disabilities (Central Sector Scheme)
3. Prime Minister's Scholarship Scheme for Central Armed Police forces and Assam Rifles.
4. Post Matric Scholarships for SC/ST students.

- Note:**
1. The students who are granted free ship in any of the above categories cannot avail reimbursement of tuition fee in the form of any other scholarship. They have to give an affidavit that they are not availing any other scholarship from anywhere which reimburses full or part of the tuition fee.
  2. Free -ship in any of the above categories would be discontinued if the student indulges in any act of indiscipline or violates the code of conduct.

## 6.2 Postgraduate Programmes

### 6.2.1 M.Tech. Programmes

(a) The students (of each category) admitted to M.Tech. Degree Programmes on the basis of GATE result, may get assistantship as per AICTE norms. Grant of assistantship is subject to the availability of funds and the fulfillment of conditions for such award. The candidates admitted without GATE score shall not be entitled to the above assistantship.

(b) Every student must submit online application for grant of assistantship in the prescribed form as per AICTE schedule.

1. Post Graduate Scholarship is entitled only to those students who are admitted in the course with a valid GATE/GPAT score at the time of admission. Any student who qualifies the GATE/GPAT exam after the date of admission shall not be eligible for grant of scholarship for the reasons whatsoever it may be.
2. The grant of Post Graduate Scholarship is subject to the condition that the student does not receive any financial assistance in shape of scholarship/any emoluments, salary, stipend etc. from any other source during his/her course of study in the Institute.
3. Foreign students, sponsored candidates and candidates admitted in PG programs through management quota are not eligible for the Scholarship.
4. It will be obligatory for every post-graduate student to undertake 8 to 10 hours (per week) of work related to teaching and research activities as assigned to him/ her by



the Institute. This could include tutorials, laboratory classes, development and maintenance of laboratories, assistance in research and development activities undertaken by faculty members, maintenance and operation of Computers and other central facilities, assistance in library, etc.

5. The Scholarship will be granted to the student on a monthly basis subject to the satisfactory academic performance and adherence to University/Institute norms/rules and regulations as applicable time to time, certified by the Head of the Institute and obligatory work as per item (4) above.
6. PG Scholarship is not admissible to passed out students taking 2<sup>nd</sup> time admission on the basis of re-qualifying GATE/GPAT exam who have already availed the scholarship from AICTE or any other Centrally funded Institution like- IIT's, NIT's and IIIT's etc.
7. The Scholarship is tenable for 24 months or for the duration of the course i.e. from the date of commencement of classes till the date of completion of the classes whichever is lower and is not extendable under any circumstances.
8. The rates of PG Scholarship is subject to change as per the notification issued by Department of Higher Resource Development (MHRD), New Delhi from time to time with the approval of the Executive Committee of the Council.
9. The student shall be required to give an undertaking to the effect that he / she would not leave the course midway. In case any student leaves the course in midway he/she will be required to refund the total PG Scholarship drawn at the time of leaving the course.
10. The Scholarship may be discontinued at any time for any kind of misconduct by the student, like involving in the act of ragging, misbehavior etc.
11. Students are eligible of following leave:

Casual leave	:	15 days in a academic year.
Medical leave	:	Maximum of one month (30 days) in academic year
Maternity leave	:	As per the Govt of India instructions time to time.
12. The mode and procedure of payment of Scholarship to the students shall be governed by the policy decision of the AICTE as may be notified from time to time on its web-portal or through advertisement in leading English/Hindi newspapers.
13. Any belated claim preferred after one year of the completion of the program shall not be entertained.
14. The AICTE may impose any other conditions as deemed necessary from time to time and the decision of the AICTE shall be final and binding upon the recipients i.e. University/Institute/College/Student who are under the ambit of the AICTE for receipt of PG Scholarship.

### 6.2.2 Ph.D Programmes

Full time GATE qualified Ph.D. students may be given assistantship subject to availability of funds.






