Eligibility for the Award	:	i) The student must have obtained a minimum CGPA of 7.0 till sixth semester



- ii) He must have written at least one article published in PEC magazine or any magazine/newspaper
- iii) He must be able to playing at least one sport like tennis, Badminton or Table Tennis or have won any prize in athletics or any game.

Guidelines for the Award

- 1. Applications for the award will be invited once a year from the final year UG students of PEC at the beginning seventh semester.
- 2. The award will be given to the passing out students who would have written articles in well recognized magazine/PECMAG/newspaper etc. and would have played atleast one sport during the course of studies at PEC while maintaining a good academic record
- 3. The following points will be considered by the award committee.
 - (a) Quality/ status of articles in magazines/ newspaper (30%)
 - (b) Achievements in sports activities (30%)
 - (c) Academic Performance (30%)
 - (d) Any other point considered important by the Award Committee (10%).
- 4. If a qualifying application is not received, then an award may not be given in a particular year and can be carried forward to the next year(s).
- 5. The award will be given during the Annual Award Ceremony held every year. For some reasons if the same is not possible then the award shall be given at some other prestigious event.

Life of the Award

: Perpetual.

Maintenance of Accounts

: Accounts will be maintained by PEC

Surplus/ Deficit : Any surplus or deficit will be intimated to the donor on annual basis.


